

## Privacy Policy

### Scope of our Privacy Policy

BARPA applies the current Privacy Policy to its website, respecting the privacy of all personal data collected from its users. Through this Policy you can know how they are collected, treated and used. BARPA reserves the right to update its Privacy Policy at any time.

We inform you that your data will not be used for any other purpose than those mentioned below.

### Responsible for the Personal Data Treatment

The Entity responsible for the processing of personal data is Argon – Componentes Eléctricos e Electrónicos, Lda., with the NIPC 505692325 and headquartered in Rua Noé Pereira, 473, 4510-706 Fânzeres, Gondomar, which determines the purpose and means of treatment of the same.

### When and how we collect personal data

Your information is collected when you consent to subscribe to our online newsletter on our website.

### Purposes of treatment

The collected data are treated with the purpose of developing contractual relationships, disclosing commercial information about our products, services and campaigns, and will not be used outside of that scope.

Your personal data will not be used for other purposes than those described in this Privacy Policy, without it being previously informed or, if appropriate, obtained your consent.

The legal grounds justifying the treatment of your personal data by barpa are as follows:

- a) Consent by subscribing our newsletter;
- b) Personal data are necessary for the execution of a contract;
- c) Personal data are necessary for the purpose of complying with a legal obligation to which barpa is subject;
- d) Personal data are necessary for the legitimate interests pursued by barpa, provided that they prevail over the interests or rights, freedoms and guarantees of the data subject.

### Retention time of personal data

Your data will be collected and stored for the period considered necessary to fulfil the intended purposes, until you cancel your subscription to the newsletter or until the barpa does not consider it pertinent to keep them in its database.

### Who has access to data

To your data, only barpa has access, except when you are asked for consent or when it is required to comply with legal obligations.

### Where data is stored

Your data is stored on barpa servers located in the European Union and to which security and protection mechanisms are guaranteed in order to ensure compliance with the applicable privacy laws.

### Rights of the data holder

In accordance with the provisions of the General Regulation on Data Protection, you have the right to request barpa to access your personal data, as well as its rectification, erasure, limitation of the treatment that concerns the data subject or his right to oppose treatment, as well as the right to the portability of data, and also the right to withdraw consent at any time, without compromising the lawfulness of the treatment made on the basis of prior consent.

You also have the right to submit a complaint to a supervisory authority (CNPD-National Commission for Data Protection). In case you wish to exercise any of your rights or simply request information, you should forward your request to **info@barpa.eu**. In case there is any violation of your personal data, you will be informed.
